RESOLUTION NO. 02-2022_PTC Calumpit

A RESOLUTION DECLARING CARWORLD INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER AND RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD RE: THE PROCUREMENT OF UTILITY/MULTI-PURPOSE (VAN) AND SEDAN (HATCBACK) VEHICLES FOR TESDA PROVINCIAL TRAINING CENTER-CALUMPIT

Reference: Public Bidding No. 02-2022

WHEREAS, the TESDA Provincial Training Center-Calumpit posted the Invitation to Bid for the aforementioned project with an Approved Budget Contract (ABC) of **One Million Five Hundred Fifteen Thousand Pesos (PhP1,515,000.00)** in the Philippine Government e-Procurement System (PhilGEPs), TESDA-III and PTC-Calumpit websites and in conspicuous places of the same offices;

WHEREAS, said project is included in the FY 2022 APP Supplement Procurement Plan of the institution (supplemental procurement plan for FY 2022 first semester);

WHEREAS, the Pre-bid Conference for the said purpose was conducted on 20 June 2022 was attended by Carworld Inc.;

WHEREAS, two suppliers, namely Carworld Inc. and Freeway Motor Sales of Baliuag Corporation, submitted its respective bid envelopes on 04 July 2022;

WHEREAS, the opening and evaluation of bids conducted on 05 July 2022 was attended by Carworld Inc. and Freeway Motor Sales of Baliuag Corporation, wherein the technical and financial documents of the Carworld Inc. were rated as "passed" while the Freeway Motor Sales of Baliuag Corporation were rated as "failed" due to non-compliance to the requirements specified in the submission of bid documents specifically on the content of the technical component and financial component envelopes;

WHEREAS, Carworld, Inc.'s bid documents were found compliant to the documentary requirements of the procurement project and thus declared as the Single Calculated Bidder;

WHEREAS, RBAC-TWG sent a letter to Carworld Inc. on 06 July 2022, requesting for submission of post qualification documents;

WHEREAS, on 07 July 2022, Carworld Inc. submitted additional documents for post qualification;

WHEREAS, the RBAC-TWG, with approval and authorization from the Chairperson of RBAC-III, conducted a post-qualification activity to validate and ascertain the validity and authenticity of all statements and documents submitted by Carworld Inc., pursuant to Section 34 of the Revised IRR of RA 9184;

WHEREAS, on 07 July 2022, the RBAC-TWG submitted a copy of its post-qualification report (attached) to RBAC-III, attesting to the eligibility and responsiveness of Carworld Inc. to the technical and financial requirements required for the project;

NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE FOREGOING PREMISES, the members of the RBAC-III hereby **RESOLVE** as it is hereby **RESOLVED** to:




- a. Declare the bid of Freeway Motor Sales of Baliuag, Corp. as “FAILED” due to incomplete or patently insufficient documents submitted and presented, viz:
 - a.1 Contents of bid envelopes were not in order, i.e. the supposed Original Copy was enclosed in the Duplicate Copy bid documents;
 - a.2 Likewise, the bid envelope that should contain the Legal and Technical Documents was submitted/presented containing Legal and Financial Documents.
- b. Declare Carworld Inc. as the Single Calculated and Responsive Bidder for the Procurement of utility/multi-purpose vehicle for TESDA Provincial Training Center-Calumpit as follows:
 - b.1 Mitsubishi L300 (Van) Cab and Chassis Euro 4 2.2L Diesel, 5 speed manual, with the amount of Php 915,000.00 and,
 - b.2 Mitsubishi Mirage (Hatchback) 1.2L in-line DOHC MIVEC gasoline, manual with the amount of Php 600,000.00.
- c. Award the Procurement of Service Vehicles for TESDA PTC-Calumpit to Carworld Inc.; and
- d. Recommend for approval by the Regional Director the foregoing findings.
