RESOLUTION NO. 01-2022_PTC Calumpit

“A RESOLUTION APPROVING AND ADOPTING THE RECOMMENDATION OF THE RBAC-TECHNICAL WORKING GROUP (TWG) AND RESULTS OF THE EVALUATION OF BIDS CONDUCTED BY THE RBAC-TWG”

Reference: Public Bidding No. 02-2022

WHEREAS, the TESDA Provincial training Center - Calumpit advertised the Invitation to Bid for the aforementioned project with an Approved Budget Contract (ABC) of **One Million Five Hundred Fifteen Thousand Pesos (PhP 1,515,000.00)** in the Philippine Government E-Procurement System (PhilGEPs), TESDA III and Provincial Training Center-Center Websites and conspicuous places at the TESDA III Regional Office and PTC-Calumpit premises;

WHEREAS, the RBAC convened on 20 June 2022 to conduct a Pre-bid Conference to ensure compliance with the standards set forth in Sec. 22 of the Revised IRR of RA 9184;

WHEREAS, the opening and evaluation of bids scheduled on 05 July 2022 was attended by two bidders, Carworld Inc. and Freeway Motor Sales of Baliuag Corporation.

WHEREAS, during the preliminary examination of the Bid Proposals of the two bidders, Carworld Inc. was rated “Passed” and declared “Eligible”, and Freeway Motor Sales of Baliuag Corporation was rated “Failed” and declared “Not Eligible”. Hence, in accordance with Sec. 32 of the same IRR, such bid previously pronounced by the RBAC as Carworld Inc. is “Eligible” has to be examined and scrutinized under the process of Detailed Evaluation/Examination of Bids to objectively consider the completeness of the bid and arithmetical corrections;

WHEREAS, in a meeting scheduled on 05 July 2022, the RBAC-TWG presented its Detailed Bid Evaluation Report to the RBAC (copy hereto attached), and accordingly recommended the following:

“Based on the result of the Detailed Bid Evaluation pursuant to Section 30 of the Revised IRR of Republic Act No. 9184, the RBAC-TWG respectfully recommends that Carworld, Inc. with a bid amount of **One Million Five Hundred Fifteen Thousand Pesos (P1,515,000.00)** as calculated, be declared as the **Single Calculated Bid**. Hence, be subjected to post qualification in accordance with Sec. 34 of the same government Procurement Act”

WHEREFORE, in consideration of the foregoing, the **RBAC RESOLVED AS IT IS HEREBY RESOLVES** to adopt and approve the recommendation of the RBAC-TWG, and declare that the bid of Carworld Inc. with a calculated financial proposal of **One Million Five Hundred Fifteen Thousand Pesos (P1,515,000.00)** as the **Single Calculated Bid**;

RESOLVED UNANIMOUSLY on 05 July 2022 at the TESDA Provincial Training Center- Calumpit, Arce Street, Poblacion, Calumpit, Bulacan.
